We will no longer be accepting cheques that have both utilities and property tax as one payment on the same cheque.

Take the time to write out 2 separate cheques:

- 1 cheque for utilities
- 1 cheque for property tax

As stated on your property tax and utility notices they are two separate accounts.

## IMPORTANT INFORMATION

#### **PAYMENT METHOD**

We no longer accept cash as a payment method

#### HOMEOWNER GRANTS

Grant applications must be filled out every year, whether you apply online or in person

#### **BC ASSESSMENT**

BC Assessment notices get mailed out by BC Assessment. Appeal deadline information is on the back of the notice

### **Homeowner Grant**

#### **Basic & Additional**

Taxpayers can apply for the Homeowner Grants through the online portal. The tax team will review and approval each grant that comes through based on the appropriate information. You will receive a confirmation email once approved. You can still apply for the grants in person. Please read the back of your tax notice for grant qualifications.

- If you're applying for the first time, you must apply in person for the first year to verify information.
- If you are turning 65 this year and you want to apply for the Additional Homeowner Grant (ADG) you MUST apply in person at the PIB Tax Office to show proof of eligibility. As the online grant application process will not allow you to change from basic grant (HOG) to the additional grant until it's verified in person first.
- If you are handicapped and have provided the PIB Tax
   Department with the required medical certificate and or a
   handicap spouse resides with you and have provided the PIB
   Tax Department with the required medical certificate.
- The medical certificate is the FORM B, which MUST be signed and stamped by your doctor and the original form brought to the PIB Taxation Department.


