Evacuation Alerts Lifted and Evacuation Order Bald Range Fire Update – August 24, 2026 (3:30pm)

Good Afternoon everyone, here is the Bald Range Fire Evacuation/Alert Community Update

Based on today's recommendation from BC Wildfire Service Incident Command, the Penticton Indian Band Emergency Operations Committee has made the following changes to the evacuation areas on PIB IR1 Lands.
Evacuation Alerts Lifted

The **Evacuation Alerts have been lifted** for the following areas:

- Upper Reserve (Westhills)
- Lower Reserve
- Marron Valley
- All other properties on PIB IR1 Lands (except 5 properties in the Shingle Creek Area, which remain on Evacuation Order)
- Red Wing
- Skaha Hills

These areas have now returned to normal status. Please see the attached map for details.

Although the Evacuation Alerts have been lifted, conditions can change. If the wildfire threat increases, an Evacuation Alert or Evacuation Order may need to be issued again.

Evacuation Order Remains

A small portion of the Shingle Creek area remains under an Evacuation Order. This Order continues to affect five (5) properties that are still without power and water service

- **119 BIG VALLEY RD**
- **851 SHINGLE CREEK RD N**
- **791 SHINGLE CREEK RD**
- **411 BIG VALLEY RD**
- **111 BIG VALLEY RD**
- **795 SHINGLE CREEK RD**

Other safety concerns remain in the area, including hazardous trees and limited communications.

To help protect the affected homes and keep the area safe:

- Security will remain in place 24 hours a day.
- The security checkpoint will be moved closer to the affected homes.
- Signs will remain in place to restrict access.
- Shingle Creek Road is limited to local residents, emergency vehicles, authorized personnel and essential traffic only

Please respect all road closures, checkpoints and directions from emergency personnel.

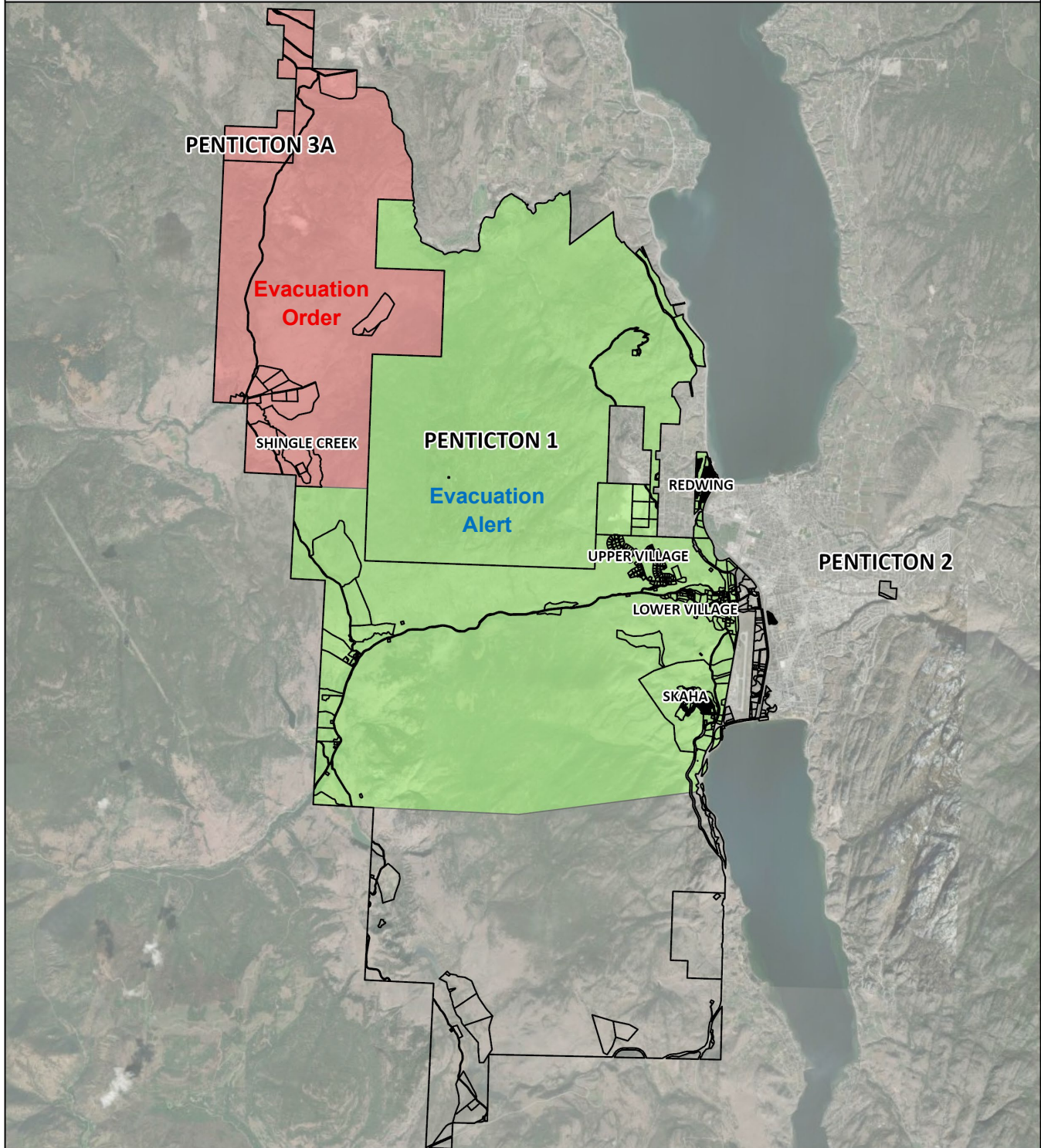

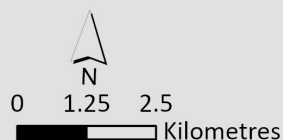
